## Who will be the 10<sup>th</sup> CPRA Winner? Now taking online applications!



On 14 February, ENCATC and the European Cultural Foundation (ECF) launched the call for applications for the 2013 Cultural Policy Research Award (CPRA). The winner of the CPRA 2013, worth 10.000 Euro, will be publicly announced in November in Belgium during the CPRA Ceremony and 10<sup>th</sup> CPRA Anniversary Celebration.

Candidates (who must hold at least a M.A. degree in social sciences, art and humanities, or public policy research, and must be no older than 35 years old) must submit their applications for the 2013 CPRA by **Friday, 31 May 2013** through the online application form on the CPR Award website.

The Cultural Policy Research Award was initiated in 2003 by the European Cultural Foundation (ECF) and Riksbankens Jubileumsfond. Since 2008, the Award has been developed in partnership with and managed by ENCATC. The CPRA annual competition encourages the next generation of cultural policy researchers to undertake comparative and cross-cultural applied research that can inform policymaking and benefit practitioners active in the field. The Award is devoted to innovative research projects which contribute to new knowledge in the field. It brings visibility and recognition to young researchers and affiliates them with a community.

The prestigious international jury includes: Lluís Bonet – President (University of Barcelona, Spain), Eleonora Belfiore (University of Warwick, UK), Jacques Bonniel (Université Lyon II, France), Timo Cantell (City of Helsinki Urban Facts, Finland), Sanjin Dragojevic (University of Zagreb, Croatia), Mikhail Gnedovsky (Cultural Policy Institute, Russia), Therese Kaufmann (eipcp, Austria).

Six finalists, selected amongst all applicants, will be invited to the 7<sup>th</sup> Young Cultural Policy Researchers Forum, alongside the 21<sup>st</sup> ENCATC Annual Conference in November in Belgium, where they will present their research proposals to the CPRA Jury, Forum participants and ENCATC members and major stakeholders.

# Mentors receive training for CREA.M's blended mentoring system for cultural managers



CREA.M partners met in Denizli, Turkey from 11-12 February for a 2-day training session for mentors participating in the project's developed blended mentoring kit. After the project's first phase devoted to mapping the skills, competences and attributes most sought after in cultural managers had ended, project partners analysed these results to create a guide. This unique kit for cultural managers participating in the mentoring process outlines a schedule of face-to-face meetings; each aimed at addressing the mentee's goals and desired skills to be acquired. The "blended" component of the mentoring process is an online platform for the mentor and mentee to use to keep in touch and to have offline meetings so they may continue working towards the mentee's professional and personal development. This interactive space will also allow for those participating in the process to note their progress, express challenges and frustrations, and celebrate successes as they move ahead in the mentoring relationship.

While the mentoring process will be different and personally sculpted to fit the needs to each mentee, the kit proposes learning outcomes, knowledge and skills to be improved or attained based on the results of the mapping phase completed earlier in the project. The mentors, who are encouraged to bring their own experiences and "tool kits" to the mentoring relationship, will also be provided a database of exercises, literature, and mentoring practices to assist them as they work with the mentee towards his or her goals.

Project partners Siân Prime and Adrian De La Court from Goldsmiths, University of London's

Institute for Creative and Cultural Entrepreneurship (ICCE) who have years of mentoring experience, attended the meeting in Turkey to demonstrate mentoring techniques, level three listening skills, and mentoring exercises for CREA.M mentors or those who will be training mentors in the coming weeks. It is also good practice for mentors to be reminded of what it is like to be a mentee. To this end, project partners and CREA.M mentors participated in a series of role play scenarios that may arise during the blended mentoring process and were offered advice on how to handle difficult or sensitive situations.

Now that project partners have gone through the process to match mentors with mentees, the pilot phase of this developed blended mentoring system will begin in March and run through September. The process will be monitored by the online evaluations completed by both mentors and mentees and by designated "tutors" who are in contact with all involved parties to resolve any unforeseen problems that may arise during the mentoring relationship.

The next CREA.M project meeting will be held in June in Helsinki, Finland when project partners will come together to discuss the progress of the pilot phase and monitoring of the blended mentoring system.

### Members sharing expertise

ENCATC member, Sybelius Academy in Helsinki celebrated the 15th Anniversary of its Arts Management Master Degree Program. Founded by Osmo Palonen, ENCATC board member from 1999 – 2005, and now under the leadership of Tanja Vilén, this program has realized a solid position in the European educational infrastructure. At the end of December 2012, ENCATC member, Giep Hagoort from Utrecht School of the Arts (HKU) in the Netherlands was invited to deliver a key note at the special alumni event and to offer a workshop for the arts management students.

He discussed the transformation of the traditional cultural and creative industries, into what he call The New Creative Flow of Diversity with crossovers, digital networks, and cooperative projects of independent creative professionals (in line with HKU's study from 2010). This creative flow is a possible answer to the problems and obstacles that we experience at present. The economic crisis is creating a negative climate for young creative people who want to realize their professional dreams. The traditional way of art management of existing cultural institutes does not express the urgency to innovate their management systems bottom-up. It is widely excepted that Cultural Entrepreneurship is a quality in-needed, but the government and the existing research centres do not pick up the call for for adequate survival knowledge to optimize the functioning of cultural and creative firms in the perspective of the new creative and sustainable economy.

On this occasion, a DIY workshop was organised to take the above mentioned observations as a starting point, with a central focus on the role that art management master programs can play. Together with the students, Professor Hagoort elaborated the DIY (Do It Yourself) approach to emphasize the importance of integration of self-governance. teamwork, leadership and entrepreneurship. The goal of the workshop was to sketch this integration within an individual creative business picture, including the notion of Cultural Business Modeling. "I was impressed by the involvement of the students taking responsibility for the quality of the workshop. They moderated my short lectures within the workshop, kept an eye on the time tables, and - last but not least - a small team of the group executed the observations," said Professor Hagoort.

# The role of culture in EU external relations

The Center for Fine Arts (BOZAR) in Brussels is part of a consortium awarded a project on Culture and EU External Relations. January 15th saw the kick-off of this preparatory action in the field of Culture and EU External Relation that will run until mid-2014 whose aim is to contribute to formulating recommendations for a strategy on culture in this area. This process will include a comprehensive mapping exercise and a consultation process on the strategic position of culture in EU external relations. The process will conclude with a final conference where conclusions and recommendations will be made regarding a strategic approach to mobilising the potential of culture in EU external relations. The consortium is already working on the first phase, mapping the relevant existing resources, approaches strategies regarding culture in external relations in the EU Member States, Croatia and 26 third countries. The next step will then be to consult with the relevant stakeholders, in order to explore the strategic role of culture in EU external relations. The project consortium is led by the Goethe Institut and including the following members: the British Council. the Danish Cultural Institute, the European Cultural Foundation. Institut Français. Institut fur Auslandsbeziehungen (IFA), KEA European Affairs and ENCATC member, the Center for Fine Arts (BOZAR).

Le mécénat culturel : une nouvelle voie pour les collectivités publiques ?

### 28 mars 2013 // Paris, FR

La question de la diversification des ressources se pose de manière cruciale pour le milieu culturel et les collectivités territoriales, au moment où les financements publics refluent durablement. Comment les collectivités peuvent-elles s'emparer de cette question? Quel rôle les élus et les cadres territoriaux peuvent-ils jouer dans ce processus? Quel bénéfice en retirer pour la culture, les équipements et les acteurs artistiques et culturels territoriaux?

Diversifier les ressources signifie constituer de nouveaux partenariats, tisser de nouvelles relations au territoire. La recherche de ressources privées peut donc aujourd'hui constituer une occasion de renouveler les projets culturels territoriaux. Pour les collectivités, la démarche mécénat et le contact avec l'entreprise sont aussi l'occasion d'accompagner leur évolution en matière de gestion et d'administration ou encore leur mutation structurelle dans un cadre économique contraint.

Les collectivités sont encore trop rarement investies dans la recherche de nouveaux moyens, dans la volonté d'une harmonisation territoriale démarches publiques/privées et enfin l'accompagnement pourtant indispensable acteurs culturels locaux. Elles sont néanmoins de plus en plus conscientes du rôle incontournable de la philanthropie des entreprises et des individus dans la construction des politiques culturelles locales, non seulement pour rechercher des moyens mais surtout pour ancrer durablement et profondément les démarches culturelles sur le territoire.

# Launch of "Cultural Policy Issues: New Research at Leeds" series

The Faculty of Performance, Visual Arts & Communications (PVAC) at the University of Leeds, is delighted to announce the launch of its "Cultural Policy Issues: New Research at Leeds" series. In the first three events, Professors Calvin Taylor, Kate Oakley, and David Hesmondhalgh will present their latest research on cultural policy.

The first event, "'Once more (with feeling)... value, culture and economy" will take place on 26 February from 4.30-5.30pm with invited speaker, Professor Calvin Taylor, Chair in Cultural Economy, School of Performance and Cultural Industries.

The idea of the creative economy has risen to global prominence on the back of promises of economic growth and development. Although its original inspiration might have been located within left of centre cultural experiments in urban and community regeneration/development, it was quickly annexed to a neo-liberal agenda of business-led economic growth. The global financial crash of 2008 and the subsequent failure to kick-start growth in the advanced industrial economies have prompted a critical re-examination of the neo-liberal appropriation of the creative economic imaginary. Drawing on a range of ideas, for example. network sociality, the social network market and the ethical economy, a range of authors have sought to differentiate networked forms of creative and cultural production from neo-liberalism and its underpinning economic assumptions. Central to these endeavours are the attempt to introduce differential notions of value which at the very least appeal to a pluralist political economy, and in their more ambitious forms, critical economic and social alternatives. This paper assesses the strengths and weaknesses of these positions concluding that they represent a valiant, but ultimately flawed attempt to reconcile a socially grounded concept of equity with the priniciple of economic regulation based on exchange value, a problem that can be traced at least as far back as Aristotle.

The other two events will follow in 2013 on 13 March with "Bridging the two cultures: NESTA and New Labour's cultural policy" and on 24 April with "Assessing the Cultural Policies of the UK Labour Government, 1997-2010: A Case of Neo-Liberalism?"


