ENCATC 21st Annual Conference "Rethinking education on arts and cultural management"

05-07 November in Antwerp, Belgium



How education in arts and cultural management should evolve in this challenging times? UNESCO calls on ENCATC to share its expertise



From 15 to 17 May 2013 in Hangzhou, China, ENCATC attended the international Congress entitled "Culture: Key to Sustainable Development" that was organized jointly by UNESCO with the national authorities of China and the municipality of Hangzhou. With some 450 participants, experts and global leaders, the objective of the Congress is to set clear and concrete recommendations to harness the power of culture and the creative industries for sustainable development.

The demand for culture is growing which calls for better policies, stronger tools, sharper statistics and better trained professionals, for each situation. "We are entering a critical phase of redefining sustainable development in its three pillars-economic, environmental and social. Culture is at the heart of each of them," said UENSCO's Director-General, Irina Bokova recalling the double power of culture as an economic driver and a source of social inclusion. She continued. "Enhancing culture means enhancing peoples and releasing self-esteem. The values of the culture are more than economic -- they are values of expression, participation, collective mobilization [...] We must not miss this historic opportunity to underline the vital link between culture and development."

ENCATC President, Cristina Ortega, was one of 3 panelists to share her expertise during the "Culture, Poverty and Wellbeing" session. "This work, carried out in close cooperation with UNESCO, is not a one-time isolated action, but is the result of our associate partnership with UNESCO and is aligned with our research on Culture, Welfare and Poverty. Our cooperation with UNESCO is ongoing and our aim is to contribute with our knowledge of this field," she said.

"This was an opportunity for ENCATC to exchange ideas and learn from other international experts about how culture can be a key driver in sustainable development. It's important that we can share what we learn with our members and

stakeholders who can use this in their lectures, research and knowledge exchanges, not only to improve cultural management and cultural policy education, but to make a difference at the local, regional and national level," said ENCATC's Secretary General, Giannalia Cogliandro Beyens who was also in attendance.

On 17 May, the Congress adopted the Hangzhou Declaration, "Placing Culture at the Heart of Sustainable Development Policies." One of the key messages to emerge was the need for more public-private partnerships for the development of infrastructure, museums, libraries and access to culture for all. It was agreed that the time has come, building on the important statements of principle and lessons learnt, for the full integration of culture - through clear goals, targets and indicators - into agreed development strategies, programmes and practices at global, regional, national and local levels, to be defined in the post-2015 UN development agenda. It was said that only such a concrete political and operational framework can ensure that all development initiatives lead to truly sustainable benefits for all, while securing the right of future generations to benefit from the wealth of cultural assets built up by previous generations.

was the first International Congress specifically focusing on the linkages between culture and sustainable development organized by UNESCO since the Stockholm Conference in The Hangzhou Congress builds on UNESCO's longstanding advocacy for culture as a driver and an enabler of sustainable development. In 1982, over 30 years ago, at the Mexico City Conference on Cultural Policy, UNESCO sought to show the role of culture as a vector of identity and cohesion, as well as an engine of creativity and sustainability. In 1998, in Stockholm, UNESCO adopted an action plan for concrete cultural policies. Since then, the importance of culture for social inclusion, job creation and sustainable growth has been acknowledged in several milestone United Nations resolutions and high-level declarations. The Hangzhou Congress comes at a critical juncture, less than one thousand days from the 2015 deadline and as the world debates the shape of new global post-2015 development agenda.

"Responding to the crisis with culture: towards new governance and business models for the cultural sector"

5 July 2013 // Brussels, Belgium

Every year, ENCATC engages in a policy debate with the aim of tackling an important issue in the cultural policy field. ENCATC invites its members, academics, researchers, cultural operators, policy makers, and students to attend to listen to an international expert panel and make their contribution to the European policy discussion.

As Europe is facing the most important financial crisis since after World War II, the policy debate will look more closely at "Responding to the crisis with culture: towards new governance and business models for the cultural sector". What are the consequences of the financial crisis on the cultural sector? Which strategies do cultural organisations forecast to survive when European and national subsidies are being cut? What are the keys to success and challenges? And which new business and governance models are necessary in this new changing environment? Two panels of experts will take a close look at some inspiring examples of business and governance models that will certainly inspire our organisations and daily work.

Invited experts include Paul Dujardin, General Manager of the Centre for Fine Arts of Brussels; Julek Jurowicz, Managing Director at SMartBe; Gunther Broucke, Director of the Brussels Philharmonic; Jean-Pierre Baeyens, holder of the Marketing Chair at the Solvay Brussels School of Economics Management (tbc); Wim Van de Keybus, choreographer and filmmaker at Ultima Vez; Arantxa Mendiharat, Coordinator of the project Conexiones Improbables; and Lluis Bonet, Director of the Doctoral and Graduate Program on Cultural Management at the University of Barcelona.

This event initiated by ENCATC is designed and implemented in close partnership with the University of Antwerp, the BOZAR, the Cultural Contact Points Wallonie-Bruxelles and Vlaanderen.

Happy Hours Project Discovering the cultural side of CPAS Brussels



On 29 April, the 3rd Cultural Happy Hours organised an evening visit CPAS Brussels (Public Centre for Social Welfare) to discover its much lesser known cultural heritage collection. Guests, who included cultural operators, European cultural networks and policymakers, were welcomed by Christophe Pourtois, Member of the Conseil de l'Action Sociale de Bruxelles, for a networking cocktail followed by a guided visit of the collection by David Guilardian, Curator of the Museum.

This institution is undoubtedly known for its significant impact on the lives of many Brussels inhabitants. It is the largest organization of its kind in Belgium and is responsible for the public welfare of the city's 170,000 residents through various forms of social aid and action (financial support, medical aid, legal advice, housing...) and a series of institutions (hospitals, retirement and nursing homes, orphanages...).

During the guided visit to the **Museum of CPAS Brussels**, our Cultural Happy Hours guests learned more about the **profound impact** the CPAS Brussels has had on the city's residents as well a glimpse of its **valuable artistic collection**. With the insightful commentary and captivating storytellings, curator David Guilardian guided participants as they were introduced to the collection that included paintings, sculptures, religious art, silver artworks, medical instruments, and photographs. These items on display reflect not only CPAS' rich history, but also how it has cared for the Brussels community and how the city fought against poverty and disease over the past several centuries. How understanding heritage can help to better understand literature

On 4-7 April in Toronto, Canada, the ENCATC Thematic Area "Understanding Heritage" Chair, Professor and art historian Claire Giraud-Labalte, contributed her 2013 expertise at the American Comparative Literature Association Annual Meeting, in the Seminar " Occupy the Territory: Mapping and Unmapping Social Space in Nineteenth-century Europe". This event presented a unique opportunity to explore a multidisciplinary and intercultural approach to understanding 19th century French writings and literature. Researchers from Canada, France, and the United States shared their knowledge on the use of different digital techniques, databases, and management of quantitative and qualitative information to map and better understand the ideas and mobility of Bohemian artists, intellectuals, writers and other cultural influencers in literature.

While literature itself is a kind of heritage that captures the thinking and ideas of a time - take Notre-Dame de Paris by Victor Hugo or Consuelo by George Sand - there are other types of heritage and research that provide another "complementary" window into understanding the literature of this period. As the only art historian invited to share her expertise, professor Giraud-Labalte presented her paper on "The Journal of Prosper Barbot (1798-1877): The man and his view of the 'other' through his travels". She spoke of the routes he took in France and Italy, all sorts of obstacles he encountered, his life in an artist colony, and young architect-painter's many meetings on his way to Rome and his trip across the peninsula.

ENCATC launches Call for its 4th Annual Research Session

4th Annual ENCATC Research Session is to be organised in the framework of the 21st ENCATC Annual Conference, "Rethinking education on arts and cultural management" (5-7 November 2013) in Antwerp, Belgium.

Researchers, academics and practitioners from Europe and beyond are invited to submit their papers by **5 July 2013**. Papers that consider one or more of the following topics will be considered: Arts and culture education - Cultural policy and management - Culture and local, regional and national development - Cultural heritage management - Cultural and Creative Industries - Culture and external relations - and Cultural networking.

ENCATC particularly welcomes papers having a special focus on: Methodologies for education and training in the field of cultural management and cultural policy - Culture, wellbeing, and human development - Measuring values and performance in the arts and cultural sector - Leadership in the arts and culture sector - and Re-thinking education.

The Annual Research Session will be organised into parallel sessions for authors to present their work to an international audience of academics, researchers, students, arts and culture decision makers, community leaders, cultural operators and artists, from over 39 countries who will come to listen and reflect on the latest developments, research, theory and trends in the large field of cultural management and cultural policy education.

This year's Annual Research Session in Antwerp will build on the success of the previous Research Sessions organised in London (2012), Helsinki (2011), and Brussels (2010). Since its creation in 2010, over 70 authors have presented their work, coming from across Europe, but also Australia, Brazil, Japan, Malawi, Turkey and the United States. ENCATC's dedication to sharing, exchanging and reflecting on these topics proves once more the network's aim to strengthen the European research area and to build knowledge societies. To further these aims, all papers presented at the ENCATC Research Session in Antwerp may be resubmitted for publication in the **ENCATC Journal of Cultural Management and** Policy, edited and published by ENCATC.

Record number of applications for the CPRA and YCPR Forum

2013 has been a record year for application submissions to the 10th Cultural Policy Research Award and the 7th Young Cultural Policy Researchers Forum. With a combined 128 applications, young researchers from Europe and beyond are highly motivated to participate in both initiatives.

The international <u>Cultural Policy Research Award</u> jury will choose **6 finalists** from the applicant pool will be invited to attend and present their innovative cultural policy research proposals during the Young Cultural Policy Researchers Forum to be held from 4 -5 November in Belgium. The winner will be unveiled on 5 November during the 10th Cultural Policy Research Award Ceremony to an international audience of researchers, academics, professionals from the cultural and education sectors, students, policy makers, artists and media from more than 35 countries who support excellence in cultural policy research.

Over 90 young researchers from 51 countries from around the world have applied to attend the 7th YCPRF. The selection committee will invite 45 promising young researchers to attend the event to participate in a programme that will include plenary sessions with established experts and renowned cultural policy researchers, workshops, networking opportunities and more. This is an excellent environment to discuss key issues and hot topics, strengthen their analytical skills and methodology approach, and network and find new partnerships. "Having this context where the focus is on young researchers is quite a plus. Trying to find your way among your peers is rewarding. You can speak up, engage and build your network for the future," said Christiaan De Beukelaer, 2012 YCPRF participant and winner of the 2012 Cultural Policy Research Award.

The Cultural Policy Research Award was initiated in 2003 by the European Cultural Foundation (ECF) and is developed in partnership with and managed by ENCATC since. The YCPRF is an initiative developed by ECF and ENCATC, as part of a larger collaborative project involving the CPRA and the Online Young Researchers Forum.

CREA.M is piloting its unique blended mentoring kit

GREA.M

After a long phase of research and exchanges with project partners, cultural managers, educators and mentoring experts, CREA.M has finalized its unique Blended Mentoring programme. With the aim of supporting cultural professionals in their understanding of the complexity of the cultural and creative sector and in taking responsibility for their career, personal development and job search, CREA.M has studied and developed a series of mentoring strategies and tools to foster entrepreneurial skills and creative thinking. The pilot phase of this Blended Mentoring programme is currently underway in 6 different countries to be tested beginning in March and to continue through September 2013: the Czech Republic, Finland, Italy, Spain, Turkey and the United Kingdom.

Mentors selected for the pilot phase went through an intensive training in order to transfer the innovative approach, practices and tools for their mentoring. Mentees were invited to attend a briefing on the mentoring journey they were about to start. Six tutors coordinated these preparatory actions, ensuring assistance for all the mentoring participants. In addition to the tutors who provide support the mentor-mentee couples, CREA.M also provides an online platform for mentors and mentees to use during, their distance mentoring sessions and so they can be part of the larger CREA.M community. There are currently 19 couples of British, Czech, Finnish, Italian, Spanish and Turkish mentors and mentees working together in face to face and online meetings twice a month to test the effectiveness of the mentoring methodology to empower cultural professionals in their entrepreneurial skills.

A rigorous monitoring and evaluation strategy is following all the parallel mentoring processes taking place in the different countries necessary for the kit's final validation. Monitoring and evaluation tools such as online diaries, questionnaires have been developed and interviews have been scheduled to record both the impact and outcomes of the entire CREA.M blended mentoring programme.

The results of the CREA.M project will be presented at the 21st ENCATC Annual Conference (5-7 November 2013 in Antwerp, Belgium) on the project website and in conferences taking place at national level in the partners' countries.

The CREA.M blended mentoring programme aims to become an innovative training model for cultural managers in Europe. The project is structured to involve and bring together different stakeholders and cultural organisations and encourage them to adopt a European perspective in their vision, policies and training as bodies linking the VET system and the labour market. A crucial dimension of CREA.M is connected to creativity and the growth of an entrepreneurial spirit to be promoted not only as a key competence for the arts and culture managers but also as interpersonal, cross-sectorial skills that can help job orientation and placement in people's career.

Interview with Blanka Chládková SETKÁNÍ/ENCOUNTER Festival 2013





For this month's first ENCATC in Contact, we interviewed Blanka Chládková, ENCATC Board Member since 2009, and lecturer and vice-dean for development and external relations of Janacek Academy of Music and Performing Arts in Brno (JAMU), Czech Republic. We wanted to learn more about the opportunities and impact of JAMU's SETKÁNÍ/ENCOUNTER Festival, an international festival of theatre schools with a twenty-two year long tradition. The uniqueness of this festival lies in the fact that the main organizers are students of JAMU's Theatre Faculty. Each year the festival gains more and more prestige mainly thanks to the participation of student ensembles of theatre schools from all over the world.

ENCATC: How does this festival provide students with an opportunity to professionalize and internationalize their profile as a future cultural manager?

Blanka Chládková: The SETKANI/ENCOUNTER Festival gives students a chance to work with international art teams that are coming to Brno for 5 days in April. But this cooperation is not restricted to these 5 days, since student organizers begin the communication with theatre schools in June a year before. But the question was not when but how... what they can gain. Besides everyone developing their communication skills in foreign languages, students gain deep understanding of different cultures, approaches in the theatre making process, and ways of dealing with professional printing houses or with the Czech TV channel. Those working as stage managers are solving sophisticated requirements for equipment needs of theatre groups coming from around the globe and all students are actively involved within the City of Brno's professional theatre environment as festival requires renting of several professional venues. All organizing participants make new contacts, new friends for future international professional projects and in the end it is a successful theatre event that they gained as they organized it as a student team with very cautious supervision of their lecturers.

ENCATC: How are the students who put on the festival evaluated?

Blanka Chládková: Students of bachelor study programs of theatre production management and stage management are involved in the festival because the festival is a part of their curricula. It means that there are particular criteria of assessment according to a year or grade that is studied by a student in accordance with the activities that they are responsible for. The graduating year students are the top managers of the festival, they are creating their production teams together with others and as top managers are setting the aims and goals of the team, but also of its particular members during the planning process for the festival. For graduating year students the festival becomes a graduation project (if they want to), that means that also the planning, interim report and post-production documentary paperwork is the part of teaching process of project management of my colleague Hanka Krejci.

And I do not want forget to mention the extreme support and participation of students of artistic disciplines. The Festival could not be so great without directors, dramaturgist, actors, students of clownery, scenographers, students of audiovisual documentation and many others (you can see the output of their work on the web page http://www.encounter.cz and even in TVEncounter on Youtube).

ENCATC: What is the economic impact on the city of Brno?

Blanka Chládková: Students can use festival SETKANI/ENCOUNTER as a laboratory for their research and they already have used it many times. In 2009 it was our master student Jiri Matousek, who proved the festival's economic impact (multipliers included) within the South Moravia Region. Each 1 Czech Crown invested to the festival from public budget generates 3 Czech Crowns to the regional economy. This year student of bachelor study


programme, Michaela Sebestova, decided to repeat the research and the outputs of the measurement should be presented by the end of May 2013.


ENCATC Does the festival have an impact on Brno's image? If so, how?

Blanka Chládková: For sure it has. First of all it is a unique situation for Brno to have international theatre groups in such intensity for five days. As the festival takes place in the beginning of April it is the first big cultural activity of the spring and summer part of the season. And I think that student organizers together with students of arts disciplines take in account the needs of the pubic space of the city to be reanimated after a long winter. As the theatre performances are focused on the professional and public community and the students from participating schools, we wish to offer residents in Brno our off-programme and make it easily accessible thanks to street performances, artistic interventions, festival visual activities etc.

ENCATC: How many ENCATC members are also implicated in the festival? What is the added value of working with other members of the network (for the festival and for the students?)

Blanka Chládková: It differs year to year. The interests of ENCATC members are different as ENCATC's broad mission umbrellas different types of cultural management and cultural policy research actors. But for those who are interested in arts management in performing arts and those who are searching partners for future student and teacher exchanges, the festival SETKANI/ENCOUNTER is very good meeting point. And we were happy this year to get the auspices of ENCATC, we're very proud to present it in the festival communication towards the participants, but even towards the different governmental bodies (as the festival is dealing with visas and mobility issues of the participants very much). To sum it up 2681 theatre tickets was bought for 31 performances in the main program, so 2681 theatergoers might read about ENCATC in the bulletin of the festival and everyday review newsletter MeetingPoint.

> Interview with Nicola Mascia Brussels Philharmonic



ENCATC PRAXIS makes a difference in the careers of young cultural managers



ENCATC first introduced its PRAXIS Newsletter back in 2008 to promote student mobility aimed to provide interesting capacity building and traineeship opportunities to students enrolled in ENCATC member institutions studying arts and cultural management and policy. In 2012 alone, PRAXIS offered over 134 opportunities in 20 countries and with a strong balance of offers in the cultural sector (heritage, performing arts, cultural and creative industries, museums, visual arts, design, etc.).

To hear directly from students who have benefited from this ENCATC service, back in May 2012 ENCATC interviewed Nicola Mascia. Through PRAXIS he had found his internship at the award-winning Brussels Philharmonic in Belgium. At the time, we wanted to learn more about his traineeship and why he had chosen to expand his professional profile with an experience abroad. Since completing his traineeship, Nicola has been employed full time to work as a Project Manager for the Philharmonic.

Almost a year later ENCATC has caught up with Nicola to see what he's doing and what awaits him in his professional career.







ENCATC: What is your current job and responsibilities? Are these different or how have they evolved from your responsibilities during the traineeship?

Nicola Mascia: I'm now in charge of coordinating and managing short-term production for Brussels Philharmonic. My production team colleagues take care of planning concerts, rehearsals and recordings and in the few weeks before the show I help to organize the performance. I'm responsible for the composition of the orchestra according to artistic and practical needs, I rent the instruments the orchestra needs and I'm in charge of logistics related to the production. This includes the movement of our technical crew, soloists and conductor and off course instruments. My actual job is totally different from the internship in May 2012. I was an intern in the communication office, in charge of social networks and sometimes simple advertising campaigns. I asked to spend more time with the orchestra and slowly I was involved with the production team. I spent three months as a researcher for my final dissertation and during those last months I was asked to join the team.

ENCATC: Following your education at University of Bologna's GIOCA programme in cultural management, you chose to leave Italy to have a professional experience abroad. What have been the most positive and challenging experiences on this professional journey?

Nicola Mascia: The GIOCA experience was of great help. I was used to speaking in different languages and working in an international environment, but it was not easy

though. Brussels Philharmonic is a Flemish-speaking institution and I didn't know the city, but luckily my colleagues helped me out. The internship was very positive because of the possibility to follow the orchestra and blog about concerts and tours. Then I started to help the production team and for sure the German tour was challenging. I spent one week on tour with the orchestra and few days later I became member of the crew.

ENCATC: What are key pieces of advice you would offer to other cultural management students who wish to follow a similar path and gain professional working experience abroad?

Nicola Mascia: Everyone lives a different experience, but there are three criteria that worked for me. First, I suggest being picky about the internship, mostly if you are doing it without any reimbursement it is important to put in the CV something catchy. Then I think time has a great value, it is worth putting it in something we really like to do. So if the internship is not what you expected or if nobody is actually tutoring you then is better to be honest and spend your time in something useful. Last but not least, in Italy we say "sposare la causa" so it is always good to embrace the project of the hosting organization.

ENCATC: Through the PRAXIS Newsletter, ENCATC aims to encourage student mobility and the internationalization of careers. According to your personal experience, how do you think international mobility and exchange may be useful to people working in the cultural sector?

Nicola Mascia: Nowadays the cultural object itself has become international. Any product of the cultural sector, from paintings to scripts, books, music and films acquires value because is shared in wide communities. Any student should have the opportunity to experience different a perspective of cultural management and cultural consumption. In this way we are ready to offer wider networks to projects worth sharing.

ENCATC: What is next for you at Brussels Philharmonic?

Nicola Mascia: Next step is the concert tonight! And also a Dutch class... Right now I still feel I need to improve and learn from my colleagues, so it's too soon to make plans.

Melting Pro. Laboratorio per la Cultura launched the first Synapse Workshop in Italy in collaboration with Adrian De La Court from the Institute for Creative and Cultural Entrepreneurship (ICCE) at Goldsmiths, University of London. The results was a one and a half day intensive workshop held from 21-22 May gathering participants with different backgrounds in the cultural and creative sector: theatre, dance, arts management and even the food industry. Organized at the HUB Rome, the Synapse workshop guided the 12 participants based in Italy through a dynamic process of group working to stir their creative ideas, identify their tangible impact and understand the change they want to make in their sectors.

People were encouraged to break the rules used so far in thinking about their jobs and projects through a series of practices based on industry and asset mapping, skills mapping, entrepreneurial modelling, design thinking, creative playing. The creative process in which Adrian De La Court re-immersed the group contributed to the construction of a collaborative and inspiring atmosphere that made the workshop effective and highly appreciated by participants for its innovativeness and power.

Synapse represents one of the first steps that Melting Pro has taken to introduce the needed change in the Italian cultural and creative sector, starting from the simple and strong belief that "small changes are radical".



General Assembly approves 6 new members and re-elects EFA President

The 2013 General Assembly & Conference of the European Festivals Association (EFA) took place from 18-21 April in Granada, Spain, and was hosted by the Festival Internacional de Música y Danza de Granada. It was the opportunity for 145 delegates representing 66 festivals from 35 countries to meet peer colleagues, to exchange on what is at stake in the world of festivals all over Europe and beyond, and to identify festivals' contributions to today's world. During the events the General Assembly, the Association representing 109 festivals from 44 countries re-elected its current President Darko Brlek.

Upon his re-election, he expressed his ambitions for his next term: "I have seen the Association grow and develop. EFA has become a modern network that implements numerous artistically, educationally, politically oriented activities. During my next term, we will continue our work in four fields: 1. artistic and cultural exchange and collaboration; 2. training for

the next generation of festival leaders; 3. dialogue with policy makers; 4. exchange of know-how on and first-hand insight into festivals; and 5. collaboration with colleagues across the world. This role can be realised thanks to a devoted work plan, a broad, active membership, dedicated Vice Presidents and Board members, a committed Secretariat, and close collaboration with partners from all over the world."

Furthermore, the General Assembly admitted six new members from six countries: Festival d'Automne à Paris (interdisciplinary; France); Usedom Music Festival (music; Germany); Riga Festival (music, Latvia); Menuhin Festival Gstaad (music; Switzerland); Turkish State Theatres (theatre; Turkey); and the Bulgarian Festivals Association (interdisciplinary; Bulgaria).

EDUCATION / COMMISSION: LLP Programme expands to welcome Montenegro

On 24 May 2013 Montenegro signed a Memorandum of Understanding (MoU) establishing its full participation, for the budget year 2013, in all the actions of the European Commission's Lifelong Learning Programme. This participation will encourage and facilitate the free movement and residence of students, teachers, trainers, trainees, university administrators, young people and other eligible persons moving between Montenegro and the Member

EDUCATION / COMMISSION: Stimulating cooperation between universities in Europe and Tunisia

On 14 May, the European Union agreed on additional funding to further develop the modernisation of higher education as well as the international cooperation capacity of higher education institutions in Tunisia under the Erasmus Mundus and Tempus programmes. This will mean more funding for universities in Tunisa and Europe to cooperate together on transnational projects. The funds will also provide more scholarships to Tunisian students

EDUCATION / COMMISSION: Moving Europe beyond the crisis

On 29 May, the European Commission adopted recommendations to EU Member States designed to move Europe beyond the crisis and strengthen the foundations for growth. These recommendations are based on detailed analyses of each country's situation and provide guidance to governments on how to boost their growth potential, increase competitiveness and create jobs in 2013-2014. Taken together, they represent an ambitious set of reforms
