

A Cultural Coalition for a Citizens' Europe

Dear Members, Dear Colleagues,

ENCATC invites you to attend "A Cultural Coalition for a Citizens' Europe" Conference to be held in Brussels from 16-17 November 2012. This two-day event is produced by the European House for Culture, the Marcel Hicter Foundation, the Access to Culture Platform, and a Soul for Europe in partnership with the Festivals Association, European ENCATC, EUNIC and Felix Meritis to discuss the future of the European project and the citizen's role in making it a reality.

Developing citizenship in Europe is one of the essential needs that should be addressed during the European Year of Citizens 2013. "Through its engagement in this event, ENCATC and the conference organisers believe culture is the key to increasing this spirit of citizenship," said Giannalia Cogliandro Beyens, ENCATC Secretary General. The cultural backgrounds of European citizens are an integral part of a cultural process that will mark the change from a national to European solutions to the complex issues surrounding contemporary life and their practice will lead to a new balance of power between citizens and powerful stakeholders.

The lectures and workshops in this encounter will move beyond the theoretical, legal, and philosophical discussions and show that citizenship and its cultural component is something we should practice in our daily lives. The event also aims to emphasize that arts and culture do not only bring "added value" to citizenship and governance, but are the core, the driving force, which

allow and push us to re-evaluate these concepts, thus strengthening democracy and human rights. Together we will examine the applicability of general concepts and specific topics within the scope of the cultural component of citizenship.

The discussions will establish a link between culture and citizenship and the crises that are currently affecting Europe: financial, economic, social, environmental, as well as a "loss of direction." Speakers will discuss the "Cultural Coalition for a Citizens" Europe" and its role in developing the future of Europe. In the midst of these crises, investigate the state of democracy and cultural rights in Europe, revealing how the active involvement of citizens can be the basis for all future development at the local, national, European and global levels, and explore the role of fear and resentment in the decline of civic values.

Finally, this event will demonstrate that policies should inspire citizens to act on their own responsibility and convictions for the benefit of a shared Europe, pursuing their own individual activities to further the common European project. The ultimate aim is to endorse the fundamental right to access culture and advance the search for creative manners in which to develop a European citizenship based on its cultural component.

On Monday 15 October, ENCATC's Journal of Cultural Management and Policy was made available to the general public via the ENCATC website. As one of the **ENCATC** membership benefits, the Journal had already been available **ENCATC** online to members for early consultation.

With this newest issue, ENCATC wishes once more to stimulate the

debate on the topics of cultural management and cultural policy among scholars, educators, policy makers and cultural managers. The Journal is based on a multidisciplinary perspective and aims to connect theory and practice in the realm of the cultural sector and to be a platform for multidisciplinary debate and new perspectives among researchers. The Journal's publication responds to the increasing need to align education in cultural management and cultural policy with research being conducted in the field.

"This journal is meant to complement the existing publications on cultural management and cultural policy education and not to compete with them. Our peer review team has done a splendid job and we are very proud of having among our Advisory Board members and guest reviewers the most renowned experts and researchers on cultural policy and cultural management education in Europe and beyond", said GiannaLia Cogliandro Beyens, ENCATC's General Secretary at the occasion of the launch of this new issue.

The newest issue is composed of five articles covering

cultural management and policy issues coming from Canada, the Czech Republic, Finland and the United States. The second contribution from Finland presents a case study for the inclusion of practical learning in cultural management and is followed by the third contribution from the Czech Republic that presents an interesting view of the evolving management model of Czech symphonic orchestras. Next, readers will be taken to the United States for a look at how cultural education towards creative entrepreneurship has had an impact on the Native American Hopi people who live in the arid highlands of northern Arizona. Finally, the Journal concludes with a practical look at projects as the institutional context for cultural managers based on EU funded development projects in the field of event management and an artistic project for the European Capital of Culture 2011.

Speaking about the launch of the second volume and the ongoing fiscal crisis, ENCATC's President, Cristina Ortega Neure said, "In the present context of crisis, tools such as the ENCATC Journal facilitate the transfer of knowledge between researchers/ academics, cultural workers and cultural policy makers and such tools are becoming especially important in order to foster smart, sustainable and inclusive growth."

To be held in Brussels from 5-7 December, the ENCATC Academy on Cultural Relations and Diplomacy promises to be an exciting 3-day learning programme. This event is a joint initiative of ENCATC, the European network on Cultural Management and Cultural Policy Education and Goldsmiths, University of London, a leading higher education organization, delivering postgraduate programmes in this field.

The aim is to deliver an intense learning opportunity to participants to further develop their knowledge and expertise in this field and prepare them to deal with challenges in cultural relations and diplomacy. The Academy combines a range of learning formats, that includes presentations, interactive discussions and sharing of views with key speakers and expertise between all participants. This cooperative programme will also offer practitioners and decision makers an opportunity to expand their personal and professional networks and establish future project partnerships.

This is a time of rapid change for cultural relations and diplomacy given technological developments that shrink time and space and open participation in international exchange to a wide range of actors (individuals, NGOs, corporations, governments and international organisations). At the same time, the present financial crisis places constrains on the funds available for international cultural activities. Reflection on the present state of affairs and its future evolution is important for all those concerned with or involved in cultural relations and new international strategies.

The Academy provides participants with the opportunity to explore and discuss some of the important concepts used in the area of cultural relations and diplomacy, as are the cases of public diplomacy and soft power. However, more than terminological nuances, our aim, with the collaboration of invited speakers and the experience and insights of the participants, the agendas, arenas, processes and structures involving international actors and how and why this is changing.

In this edition of the Academy, one of the main foci is governmental policy and activity in cultural relations, as despite the increasing importance of non-state actors participating in the international arena states largely remain the most important actor in international relations. However the role of the commercial sector has grown and in some interactions has far greater resources.

However, the way states develop cultural diplomacy is changing radically due to: ICT and (mobile) social media; there is a need to engage and network with a wide range of other actors on an increasing variety of issues that involve cultural relations, such as development and security; the acknowledgement of the importance of the actions of other actors, such as those from the Media and the Commercial sector. Increasingly non-governmental actors operate transnationally at international, regional and local level (for example in the case of BOZAR, a hub of cultural activity), and further contribute to the blurring of the domestic/foreign divide. Times are changing for all those involved in international activity and the future is uncertain, however the potential in the area through technology will be outlined by wearefuturegov.com

In this first edition of the ENCATC Academy, Europe and the European Union will be used as a case study to illustrate the complexity and the broadening of areas characterizing contemporary cultural relations and diplomacy. The importance of culture in external relations has been recognized in the EU – but how will this be achieved? The case of EUNIC, the network of EU national cultural institutes, operating internationally, will be analysed as an example of the increasingly collaborative work being developed between national governments. At the same time, the tensions between old and new ways in cultural diplomacy will be focused on by examining the engagement of the EU and its member states with China.

Human[i]ties Perspective 2012



More and more ENCATC is recognised as an expertise provider. On 5-6 October, ENCATC's Vice-President, Gerald Lidstone from Goldsmiths, University of London, represented the network at the Human[i]ties Perspective 2012 academic conference and career

orientation event held in Copenhagen.

Under the general theme of "Empowerment in a Globalized Society", the two-day conference was divided into four key research "Communication, Media and Participation", "Women's Empowerment in a Globalized Society", "European Cultural Diplomacy and Cultural Policy", "Education: Teaching Competencies Empowerment". Each session approached or integrated the humanities from a different angle, and consisted of three or four presentations from experts in the field, followed by a panel discussion.



For his contribution, Professor Lidstone delivered a presentation on "Cultural Exchange and Diplomacy in Europe", while accounting for a range of initiatives and strategies within the EU there was an emphasis on understanding that the commercial sector plays as

important a part in intercultural and inter country engagement as that delivered by the state.

Roughly 60 researchers, professionals and students from 20 countries attended the event that aimed to facilitate a collective reflection on some of the key challenges facing the humanities in the 21st century in Europe among young academics, professionals, and professors. It was supported by the DG of Education and Culture of the European Commission as part of the REALISE IT joint initiative between the Erasmus Mundus Association (EMA) and OCEANS Network.

Pleading for a Knowledge Co-creation Agenda on Cultural Entrepreneurship



On 22 October, ENCATC member Giep Hagoort, cultural entrepreneur and professor of Art and Economics at the Utrecht School of the Arts, was invited to the University of London's Central School of Speech & Drama to present his research into cultural entrepreneurship that

has argued two freedoms are fundamental; artistic freedom and entrepreneurial freedom. His presentation explored how these two freedoms can be combined to strengthen the artistic and cultural quality of our society.

He explained that existing research practice on cultural entrepreneurship is strongly focused traditional. on Western, mainly economic and policy oriented needs. In his view, traditional research has to be replaced transdisciplinary research approaches combine that



research and the creative and divers practice from artists, designers and creative entrepreneurs. In London, Professor Hagoort suggested a new international Knowledge Co-creation Agenda, which involves a transdisciplinairy research approach, new grass-roots research methodologies and studies on new organizational research forms such as Interactive Communities, Learning Labs and Mobile Strategic Labs for New Knowledge ('StratLabs').

In his presentation to a group of artists, project managers, researchers and educators, Professor Hagoort presented the research that emphasize the fact that cultural and social dimensions of cultural entrepreneurship are vital additions to predominant economic dimension entrepreneurship. Along this line, he discussed the contexts of а sustainable entrepreneurship and new bottom-up network forms of creative collaborations within creative zones and clusters. This urban approach is now executed in seven West European cities within the 'Cure' project. In this project, the Utrecht research group is responsible academic partner and for the development of a Conceptual Framework, titled as 'Creative Zone Innovator'.


ENCATC Ambassadors' Corner

International Workshop on Cultural Diplomacy



ENCATC member and Ambassador, Ihor Savchak from the Centre of Cultural Management in Ukraine, represented the network at the International Workshop Cultural Diplomacy held on 27 September 2012 in Tbilisi, **ENCATC** Georgia. presented as Europe's leading

network on Cultural Management and Cultural Policy education during the session "Building the image of organization at the international level: Real possibilities of international networks." In attendance were 20 young cultural managers from Armenia, Azerbaijan, Georgia and Poland.

This workshop focused on questions of cultural diplomacy and the significant role it plays in international relations of EU neighboring societies. In many cases, political representation of these countries often lack proficiency, credibility and trust.

Civil society leaders of these neighboring countries understand the importance of intercultural relations for the cohesive development of their nation at the national and international level and strive to build and strengthen their capacities via the cultural management field. They are passionate about local cultural community needs and initiate innovative projects in cultural industries and cultural policy reforms to achieve their aims.

The workshop was organised in the framework of the cultural cooperation programme "Cultural diplomacy - training programme for EaP cultural managers" which aims to enable participants to analyse the European and Polish system of culture management, fundraising and lobbing opportunities, international cooperation and partnership building, linking the culture and commercial sector within the creative industries. It is jointly designed and the Centre implemented bv for Cultural Management, Contrapunctum Foundation (Warsaw) and New Art Union (Tbilisi).

Understanding Heritage

Conference "Heritage and public policy of education"



Organized by ENCATC member Prokultura Split, the "Heritage and public policy of education" conference brought together researchers, educators, local authorities and experts in field of culture, education and

economics to explore the relationship between the cultural and the educational sector. This event was held on 1 October, on the occasion of the 400 year celebration of the Theatre of Hvar, the oldest public theatre in Europe.

Prokultura Ivanisevic, Head of Nansi the conference association, opened the accentuated the importance of exploration and interpolation of heritage related content in schools' curricula, stating that the main goal of the Prokultura association is exploration and introduction of new and knowledge into the existing educational system, in order to educate students with more knowledge about their heritage and identity.

The conference was also an excellent opportunity for the audience to share practical issues and, possibly, foster collaboration in order to enhance synergetic efforts to promote the values of heritage in the cultural, educational and tourist sector. The main theme of round table discussion was the recognition of local heritage as a strong factor of international affirmation and its potential to boost economic development. This is especially important today, when Croatia is finishing its part in the European integration project and the important role of the local community in this context cannot be stressed enough.

The general conclusion of the conference was that cultural policies cannot be built without a continuous dialogue and joint effort between government, local authorities and professionals in their respective field of culture, education and economics.

This event was made in collaboration with the University of Split, CEDI – 'Robert Schuman' and Decentralized service office – Split and Dalmatia Department.

Arts & Health

"Arts - Health - Entrepreneurship?"



On 22 October in Helsinki, 68 participants from six different countries attended the "Arts - Health - Entrepreneurship" Conference. The programme focused on the management and entrepreneurship within

arts and health projects. What skills and competencies are needed in the field? What does the field offer to arts/cultural operators? How to solve the challenge of funding and financing?

There have been several projects piloting new methods for using art based process to improve wellbeing of clients in social and health care sectors. Starting point of these projects is an artist working in a care unit and mediators understanding both artistic and health care interests for cooperation. These pilots have shown that in this surrounding the cultural operator needs to have good skills and specific competencies in order to make projects sustainable and successful.

A central discussion point of this event was to explore how to turn the innovative pilots into permanent practices, products and stable employment. In fact, in the context of arts and health, the sectors is dealing with activities which fall into the border area of art/culture, as well as that of social services/health care.


Participants discussed challenges to improve arts management aimed at professionals working in intermediary positions between the artists and health care units and the specific competences needed when working in inter-disciplinary surroundings. As seen in the piloted arts and health projects a central need is to find ways to enhance creative ideas into sustainable practices and entrepreneurship. The discussion also focus on financing models, client basis and value chain of production as well as service development.

This conference was an initiative of the ENCATC Arts and Health Thematic Area and was organized by the Cultural Management Degree Programme, Helsinki Metropolia University of Applied Sciences.

The organisers are preparing a pdf publication detailing the proceedings of all the papers. This will be available on ENCATC's website at a later date.

He also spoke of past works and how it is not always appropriate to use them: "We should only use art works from the past as far as they can tell us about our history." But Gerard's most important message, I feel, was simply to "Go your own way". Young festival managers in attendance left feeling inspired with new ideas and contacts.
